Abstract: The purpose of this study was to determine the effect of a 12-week training program on the physical fitness and health of sedentary middle-aged men. The subjects were 20 men, aged 40-50 years, who were sedentary and had no history of cardiovascular disease. They were randomly assigned to either a control group (n=10) or a training group (n=10). The training group participated in a 12-week program of aerobic exercise, three times per week, for 45 minutes per session. The control group did not participate in any exercise program. Physical fitness was assessed at baseline and at 12 weeks using a variety of tests, including a maximal aerobic capacity test, a submaximal aerobic capacity test, a resting heart rate test, a resting blood pressure test, a resting blood glucose test, and a resting blood cholesterol test. Health was assessed at baseline and at 12 weeks using a variety of tests, including a maximal aerobic capacity test, a submaximal aerobic capacity test, a resting heart rate test, a resting blood pressure test, a resting blood glucose test, and a resting blood cholesterol test. The results of the study showed that the training group had significantly higher values for all physical fitness and health measures at 12 weeks compared to baseline and compared to the control group. The control group had no significant changes in any of the measures. The results of this study suggest that a 12-week training program can improve physical fitness and health in sedentary middle-aged men.
